

INSTAGRAM COMPETITION TERMS AND CONDITIONS - GOPRO HERO 7 BLACK

1.- ORGANISATION

NEUS DEL VALIRA, S.A. (hereafter, GRANDVALIRA), with registered address at Av.Carlemany 68, despacho 401, Illa Carlemany - AD700 Escaldes-Engordany, Principality of Andorra, registered under commercial registry No. 917870Z, will be holding a competition within the country. This 3-page document constitutes GRANDVALIRA's Terms and Conditions for the GoPro Hero 7 Black promotion.

2.- TERRITORIAL SCOPE

The promotion is open to all countries. Nevertheless, the competition will take place in Andorra.

3.- ENTITLEMENT TO PARTICIPATE

Individuals of legal age, with real Instagram user profiles and that follow @grandvalira on Instagram may participate of the promotion.

4.- COMPETITION DURATION

The competition will start on 05/01/2019 and last 17 days, until 01/21/2019 at 23:00.

5.- COMPETITION MECHANICS AND REQUIREMENTS FOR PARTICIPATION

- a) Users must post a picture of Grandvalira that is as recent as possible on Instagram, tag @Grandvalira, @Gopro and two friends, and then add the #GrandvaliraHero7 hashtag. Shooting the picture using a GoPro will be taken into account.
- b) It is essential that users wishing to participate have a public Instagram profile.

6.- SELECTION OF THE WINNER AND RUNNERS-UP, COMMUNICATION AND AWARD

The winning picture will be selected by a jury comprised by the GRANDVALIRA marketing team. The originality and quality of the picture, as well as having been taken on a GoPro will all be favourably valued.

The name of the winner will be announced by GRANDVALIRA on social media at the end of the competition, on 22/01/2019. The user must contact the company by means of a private social media message within 7 days.
