



“Your infinity winter” PRIZE DRAW TERMS AND CONDITIONS

CLAUSE 1. ORGANISING COMPANY

NEUS DEL VALIRA, S.A. (hereinafter ‘**Grandvalira**’), with corporate address at Av. Carlemany 68, despatx 401, illa Carlemany – AD700 Escaldes-Engordany, (Principality of Andorra) with commercial registry number 917870Z, is the organiser of this prize draw.

CLAUSE 2. PURPOSE

The purpose of these Terms and Conditions is to regulate the mechanics of the prize draw and the awarding of prizes.

Grandvalira will organise a monthly prize draw as well as a final prize draw at the end of the season among all the participants who meet the requirements set out in these Terms and Conditions.

CLAUSE 3. ELIGIBILITY

The prize draw is open to all individuals over the age of 18 who meet either of the following requirements:

- 1- Have purchased a day pass or multi-day pass through the <https://www.grandvalira.com> website, ticket offices or travel agencies and/or tour operators and connect to the Grandvalira Wi-Fi once they are at the resort.
- 2- Have purchased an Andorra Pass season pass or Plus+ pass and connect to the Grandvalira Wi-Fi once they are at the resort.

Grandvalira Resorts (NEVASA, ENSISA, SAETDE, SECNOA, EMAP and SETAP) employees are excluded from the prize draw.

CLAUSE 4. AGREEMENT TO THE TERMS AND CONDITIONS

By entering the prize draw, you are agreeing to these Terms and Conditions, which will be available to participants on the Grandvalira Wi-Fi login page, and on the www.grandvalira.com page.

CLAUSE 5. TERRITORY

The prize draw is open to participants from all countries, but the prize draw will take place in Andorra.



CLAUSE 6. PRIZE DRAW PERIOD

The prize draw will run from 09.00 on 09/01/2023 to 17.00 on 17/04/2023, the last day of the season.

Entries received outside this time period will not be considered, even if they meet all other requirements or conditions.

CLAUSE 7. GENERAL MECHANICS

Throughout the duration of the draw, the customers who meet the requirements set out in these Terms and Conditions and who wish to enter must:

1. Connect to the Grandvalira Wi-Fi through their My Grandski account or, if they do not have one, create an account in order to link their pass, indicating the Wi-Fi Code or WTP number of their pass.
2. The participant must show their pass to scan its QR Code every time they use any of the resort services (restaurants* and ski schools only – all other products/services are excluded), this will increase the number of entries to the prize draw.

*In some restaurants the mechanics of participation may vary. In this case, the participant will have to access via a link or a qr that they will find on their purchase ticket and enter their ski pass code to attribute this purchase to their My GrandSki account.

Every €10 spent at <https://www.grandvalira.com> or any resort service will get the participant one entry.

Every time the participant visits Grandvalira and purchases a new pass, they will have to go through the entire process to link their pass to their My GrandSki account in order to enter.

CONSIDERATIONS TO BEAR IN MIND:

7.1 Online purchases of day passes

The person paying for the online purchase will be the one who will accumulate the entries to the prize draw.

Once at the resort, each pass holder will have to access the Grandvalira Wi-Fi in order to individually accumulate entries, which will start counting from that point onwards, according to how much they spend.

7.1 Purchases of season passes or Plus+ passes

The person paying for the purchase of a season pass and/or the amount for the days skied using the Plus+ pass will be the one who will accumulate entries to the prize draw, and they will only be considered for the final prize draw.



Once at the resort, each pass holder will have to access the Grandvalira Wi-Fi in order to individually accumulate entries, which will start counting from that point onwards, according to how much they spend. These will count towards entries for the corresponding monthly prize draw.

CLAUSE 8. PRIZES

The prizes for the **MONTHLY PRIZE DRAW** will be:

JANUARY, among all the January participants

100 one-day passes for this season or next season

10 à la carte lunches x 2 pax for this season or next season

1 pair of HEAD skis

The prize draw for the January participants will take place between 1 and 10 February.

FEBRUARY, among all the February participants

100 one-day passes for this season or next season

10 à la carte lunches x 2 pax for this season or next season

1 pair of HEAD skis

The prize draw for the February participants will take place between 1 and 10 March.

MARCH, among all the March participants

100 one-day passes for this season or next season

10 à la carte lunches x 2 pax for this season or next season

1 pair of HEAD skis

The prize draw for the March participants will take place between 1 and 10 April.

APRIL, among all the April participants

100 one-day passes for next season

10 à la carte lunches x 2 pax for next season

1 pair of HEAD skis

The prize draw for the April participants will take place between one and ten days after the resort closes, which is scheduled for 17 April 2023.



All participants will be entered in the **FINAL PRIZE DRAW**, and the **END-OF-SEASON** prizes will be:

2 ten-year Andorra Pass season passes.

CLAUSE 9. SELECTING WINNERS AND AWARDING PRIZES

9.1 Selecting winners

The winners will be chosen at random using the EasyPromos application or a similar one.

The winners' names will be announced as follows:

- Through **Grandvalira's** social media accounts and/or the grandvalira.com website and via email to the winners.

Grandvalira will notify the winners via email within **72 hours** of holding the prize draw. The winners must respond and accept the prize using the same means **within seven days**.

If the winner does not get in touch with **Grandvalira** within seven days of being notified or if they reject their prize, they will lose their right to the prize, and the prize will be awarded to the substitute winner identified by the application used by the prize draw, with up to two substitute winners. If these substitute winners do not meet the requirements, the prize will be forfeited.

9.2 Delivery of prizes

Passes will be delivered via email through a booking voucher.

Lunches will be delivered via email through a booking voucher. The winners will have to book a date and choose one of **Grandvalira's** à la carte restaurants, contacting the Grandvalira Resorts Booking Centre using the following email: infinitewinter@grandvalira.com. In any case, the winners may make the booking directly with the restaurant to use the booking voucher. The prize is a closed menu and all extra consumption will have to be paid for by the winner. Grandvalira will offer these restaurants to choose from: Restaurant Llac dels Pessons, Restaurant La Arrocería or Restaurant Wine and Meet bar by Jean Leon.

The pair of HEAD skis will be sent to the address indicated by the winner.

CLAUSE 10. PERSONAL DATA PROTECTION

In accordance with the provisions of **REGULATION (EU) 2016/679** of 27 April 2016, and **Law 29/2021, the Personal Data Protection Law**, we hereby inform you that the personal data provided is confidential and forms part of processing activities for which **Grandvalira** is



responsible, for the purpose of managing your entry into the prize draw, unless you state otherwise.
